We are delighted to extend a warm invitation to you to visit London for the seventeenth annual conference of the International Insolvency Institute. This will be our first conference in the United Kingdom. The London Conference is dedicated to the memory of III Founder, Bruce Leonard, who passed away in early 2017.

The primary hotel venue is the Rosewood Hotel, in the heart of the Legal District. We are also holding the Next Gen Program at PwC, courtesy of Mike Jervis and the Judicial and Academic programs at Freshfields, courtesy of Nick Segal. The welcome reception and dinner will be at the world renowned Tate Modern Gallery and the Legendary dinner is being held in The Middle Temple Hall, where we will be entertained by the National Youth Theatre of Great Britain who are performing extracts from Shakespeare's Twelfth Night. The Conference will be opened by a keynote speech from Lord Neuberger, President of the Supreme Court. The London venue is highly prescient with the UK due to give notice to leave the European Union in March 2017. There will be an in depth analysis of the impact on international insolvencies involving UK companies, looking at Brexit from the point of view of the UK, the EU, the US and other major jurisdictions. There will also be a session involving simultaneous hearings in two jurisdictions concerning a primary insolvency and recognition. The session will be taken by Judges from each of the jurisdictions. In addition to sessions focusing on recent legal developments there will be a session on the UNCITRAL Model law that will go into force shortly before the conference.

Additionally, we have some outstanding optional tours including a cruise on the River Thames, visits to the British Museum, Hampton Court Palace, Westminster Abby, Windsor Castle and Royal Ascot Race Meeting.

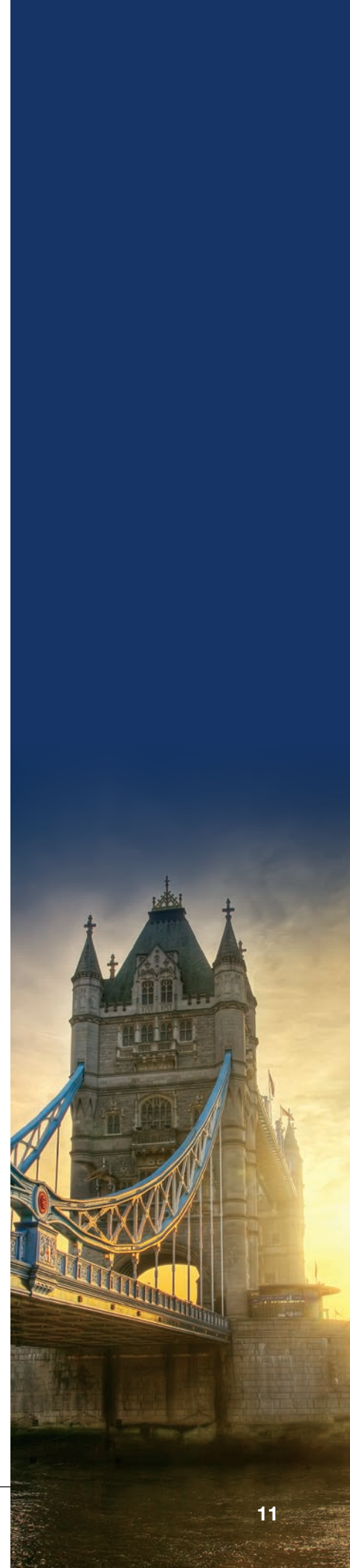

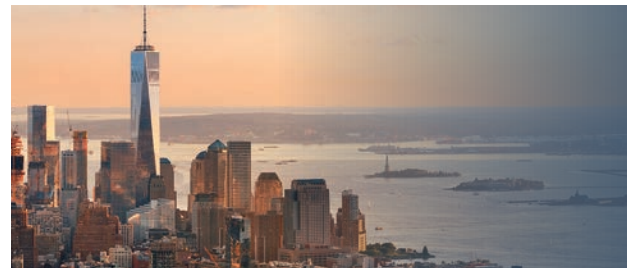
